New Business:

A motion was made by Wilkinson, 2nd by Wertz to ratify the Resolutions 2020 – 1 Proclamation of Local Disaster, 2020-2 Continued Proclamation of local Disaster and 2020 -3 Amending and supplementing the Township Tax Collection Policy. Motion carried 3-0

A motion was made by Wilkinson, 2nd by Wertz to ratify the Supervisors decision to close the Township Office during the pandemic crisis. Motion carried 3-0

A motion was made by Wilkinson, 2nd by Wertz to sign the SWM Agreement with the Penn State University Fruit Lab. Motion carried 3-0

Miller Plan: Mr. Miller presented a sketch plan to Biglerville Borough regarding his plan to build Townhouses in Butler Township so that a determination of Sewer capacity can be made. Per Jon Holmes, the lay out appears to be ok. Under current Zoning a special exception may be needed. The Planning Commission should now see this to keep them in the loop. No Action Taken.

Land Conservancy Grant Pursuit: The Township was informed that the Land Conservancy is pursuing to obtain a grant for the purchase of approximately 60 acres of land for public use. Not Action Needed.

Jon Holmes discussed this with Gil Picarelli, KPI, SEO and they both agree that an option for this holding tank, would be to do an agreement with Bond attached and filed in the Adams County Recorders office. The Supervisors have asked Mr. Holmes to follow up with Mr. Picarelli. No Action Taken
